CODE OF ETHICS AND CONDUCT SUPPORT AND SUSTAIN CHILDREN (SSCH)

In a rapidly changing world, integrity and trust are essential for building and maintaining longlasting relationships

with all our stakeholders, including beneficiaries, donors, partners, and the wider community. The association Support and Sustain Children (hereinafter referred to as SSCh) is committed to ensuring that all its activities are guided by uncompromising ethical principles.

For this reason, we have decided to implement this Code of Ethics and Conduct.

This document has been created to clearly define the standards of behavior we expect from those who work with and for the Association—whether employees, volunteers, or external collaborators. Our goal is to ensure that every action reflects our core values of integrity, transparency, respect, and accountability.

Through this Code, we aim to prevent any form of inappropriate or unethical behavior, while providing a clear reference on how to approach potentially problematic situations.

It is a vital tool for guiding everyday decisions in alignment with our core principles, and represents a commitment to ourselves and to those who benefit from or support our work.

By implementing this Code, SSCh pledges to regularly review and update its policies, ensuring they remain relevant and effective in promoting an ethical and transparent environment. In doing so, the Association positions itself as a model of ethical and responsible behavior, contributing positively to society and reinforcing the trust of all who engage with us.

Relationships with Donors and Financial Transparency

• Fund Management

Respect for Donors

Ethical Practices in Soliciting and Receiving Donations

We ensure that all fundraising practices are conducted ethically, avoiding coercive techniques and ensuring that the dignity and autonomy of potential donors are always respected.

Commitment to Beneficiaries

• Protection and Care

All individuals acting on behalf of SSCh are required to treat beneficiaries with the utmost respect and consideration. In line with our core values, we work to protect the most vulnerable—especially children, women, and the elderly—from abuse, exploitation, and

Reporting and Response

• We provide secure and confidential mechanisms for reporting unethical conduct or violations of the Code. It is essential to us that every report is taken seriously and investigated promptly, with corrective actions implemented to prevent future occurrences.

External Communication and Ethical Use of Images

• Accuracy and Honesty in Information

All our external communications—both online and offline—reflect our values of integrity and transparency. We are committed to providing accurate and verified information, avoiding the use of misleading or exaggerated messages.

• Responsible Messaging

We recognize the powerful impact of our messages and are committed to communicating responsibly. We avoid content that may incite hatred, discrimination, or any form of violence. Instead, we promote messages that foster solidarity, compassion, and equality.

• Preservation of Dignity

When selecting and using images of children and adults, SSCh is committed to maintaining the dignity and respect of the individuals portrayed. This means avoiding images that may exploit their vulnerabilities or present them in a negative light.

• Appropriate Context

Images used must always be relevant to the message's context and should illustrate stories in an honest and respectful manner. We avoid altering images in ways that may deceive or distort reality.

• Cultural Sensitivity

We strive to show sensitivity to the cultural background of those portrayed, avoiding stereotypes and respecting cultural norms regarding privacy and representation.

GUIDELINES FOR THE IMPLEMENTATION OF THE SSCh CODE OF ETHICS AND CONDUCT

Review and Update of the Code

- 1. **Training and Awareness**: All members of the organization, including new hires, will receive regular training on the policies and procedures outlined in the Code of Ethics to ensure their understanding and application.
- 2. **Review and Update**: This Code of Ethics represents SSCh's solemn commitment to upholding and promoting the highest standards of ethical conduct and accountability. It is subject to regular reviews to ensure it remains relevant and effective. Revisions are undertaken to reflect changes in legislation, industry best practices, and the dynamics of

- 4. **Responsibility of the President**: The President is responsible for monitoring compliance with the Code and serving as a point of reference for their teams regarding any questions or concerns related to the Code of Ethics.

These guidelines will help SSCh ensure that the Code of Ethics is integrated into all activities and supported by a strong governance and compliance structure. Their implementation is essential to maintaining trust and integrity in all SSCh operations.
